CAREER OVERVIEW

Ms Sower has been employed as a forensic biologist since 2003. She has prepared reports in over 1000 cases, many of which involve offences against the person including assault, rape and murder.

EXPERIENCE AND EXPERTISE

Typical cases involve:

- Undertaking a review of the prosecution findings relating to the detection of body fluids and speculative 'Touch DNA' type samples, including carrying out cold case reviews
- Interpretation of body fluid patterns including interpretation of blood patterns at scenes of assaults and murders, to attempt to construct a sequence of events
- The interpretation of DNA profiling results including complex low template mixed profiles
- Reviewing routine and advanced statistical assessments carried out on simple and complex DNA profiling results
- Carrying out examinations of items not previously examined by the prosecution, for the presence of blood, in our in-house DNA clean laboratory facility
- Arranging examination of items not previously examined by the prosecution for the presence of semen and saliva and speculative DNA sampling
- Interpretation of the significance of the scientific findings in terms of disputed accounts of events

As part of her role at Keith Borer Consultants, Ms Sower set up, validated and ran the in-house DNA profiling unit for 10 years being responsible for the analysis of a wide range of sample types. She is currently manager of KBC's laboratory facilities and responsible for the training of new staff members in laboratory techniques. She has also been responsible for the quality review of over 1000 reports prepared by other experts at Keith Borer Consultants.

Ms Sower has attended court on many occasions to advise counsel and has given expert evidence in England, the Isle of Man, Northern Ireland, Scotland, the Republic of Ireland and the Cayman Islands.
